Volunteer Roles

- The **Entry monitor** counts incoming market guests, ensures guests entering are following all market protocols, help direct guests. One entry monitor is needed at both entrances.
- **EBT/SNAP processing** happens at each info booth at the entries. This is a critical part of our operation. EBT customers can purchase tokens with their EBT cards and also have their purchases matched with Link Dollar Value Coupons. This program ensures an equitable community where any member can have access to local fresh produce.
- **Assist in the info booth** helping field shopper inquiries, selling LSqFM merchandise, and oversee compost collection
- **Little Peas Program Coordinator** is responsible for punching all little peas (kids) membership cards and inviting them to participate in the kids programming for the day. This role also may entail allocating prizes to kids with full punch cards, or educating and inviting new market goers to the program.
